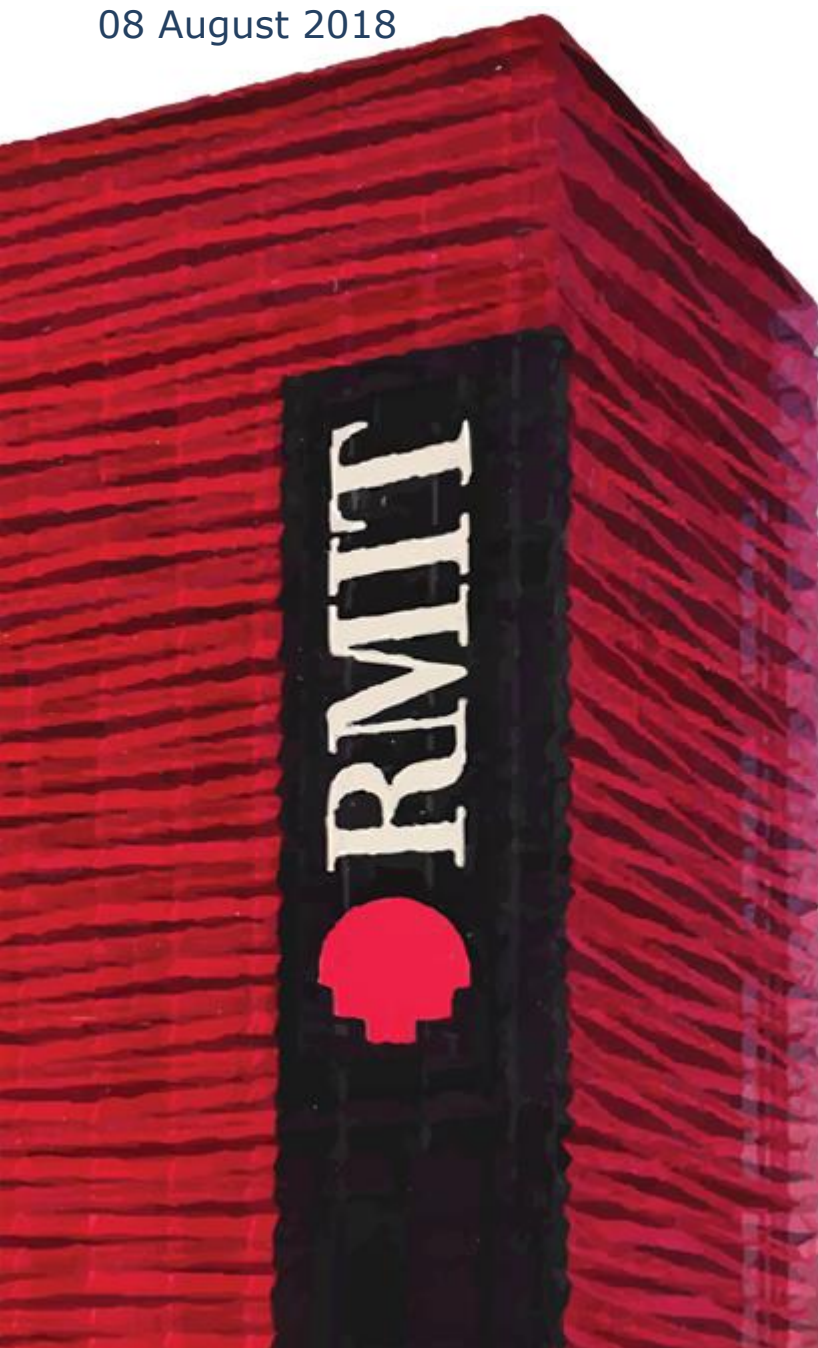

## **KEYNOTE SPEAKER**

**Professor Le Van Cuong, Paris School of Economics**

Prof. Le Van Cuong is one of the world's leading economists in the field of optimal growth and dynamic programming.

Prof. Cuong has published more than 80 scholarly journal articles in three main areas: Mathematical Economics, Optimal Growth Model and Macroeconomic Growth Models. Prof. Cuong is also the author/co-author of many academic books on Mathematical Economics. He has been assigned many important positions for French research scientists such as: Senior Research Director, Outstanding Research Director of the National Center for French Scientific Research (CNRS), Emeritus Professor at prestigious universities including Paris 1-Panthéon Sorbonne and Paris School of Economics. Prof. Cuong is a recipient of numerous awards in his distinguished academic career, including the CORE Prize in 2003.

On the occasion of his retirement in 2011, the Paris School of Economics, University of Paris 1, CNRS, University of Exeter, and the Association for Public Theoretical Economics (APET) held two scientific conferences to honour Prof. Le Van Cuong.
