Conference's Associated Journal

A limited number of high-quality papers from the conference will be invited to submit to the Afro-Asian Journal of Finance and Accounting and to be considered for inclusion in their regular issue after the presentation of their papers at the ICAFB Conference.

The selection will be done in two steps. In the first stage, the conference committee will first screen and evaluate the papers. In the second stage, authors of selected papers will be invited to submit their papers to the journal to go through the standard review process. Submissions to the journal will undergo a fast-track review process that maintains the journals' normal publication standards.

Also, selected papers presented at the conference are eligible to be considered for publication in the IUH Journal.
